1. This form should be completed in BLOCK CAPITALS, except where signatures are required, and forwarded to the Club Office. Receipt of this form by the Club does not signify acceptance of the applicant onto the membership waiting list.
2. Both the Proposer and Secunder must be Special Voting Members.
3. The Proposer and Secunder will be informed by letter of the date on which the Candidate is to meet the Interview Committee.
4. An application for membership will only be considered after either the Proposer or Secunder has accompanied the Candidate to a meeting at the designated time with the Interview Committee to introduce the Candidate. Members proposing or seconding a candidate are informed that it is necessary for one of them to attend the Interview Committee Meeting to introduce their Candidate.
5. The Proposer and Secunder of a Candidate shall be jointly and severally liable for all sums due from their Candidate to the Club up to a period of one month after the Candidate's ballot has been declared.
6. Candidates have no right to use the facilities of the Club whilst on the Membership Waiting List.
7. Each Special Voting Member may only concurrently propose a maximum of 5 candidates on the current Waiting List.
8. Term Subscribers should note their membership may be subject to termination if there is any change to their employment status and/or residence status.

## Notices relating to the Personal Data (Privacy) Ordinance

### The Club's Policy

The Club is committed to implementing the principles and requirements of the Personal Data (Privacy) Ordinance to safeguard your privacy with respect to personal data.

### Supply of personal data

You are required to supply up-to-date personal data to the Club in connection with an application for Club membership, use of the Club's facilities and services, opening and maintaining accounts with the Club, and/or matters relating to the Club's activities. Supply of personal data to the Club is non-obligatory but failure to do so may result in the Club being unable to process your application or to provide facilities and services to you.

### Use of personal data

Your personal data may be used for the following purposes:-

- (1) carrying out the Club's operations and provision of facilities and services;
- (2) conducting checks regarding eligibility for membership;
- (3) designing and marketing the Club's facilities, products and services;
- (4) meeting the requirements to make disclosure under the Club's Articles or bye-laws relating to the Club's core operations and any law applicable to binding on the Club; and
- (5) facilitating communication between you and the Club.

### Classes of transferees

Personal data supplied to the Club will be kept confidential but may be disclosed to employees, agents and consultants of the Club who shall be under the same confidentiality duty as the club, and law enforcement agencies under any law binding on the Club.

### Access to and correction of personal data

Under and in accordance with the provisions of the Ordinance, you are entitled to request for access to personal data held by the Club about you and to correct such data. You may direct your request in writing to:-
