**Notice of Annual General Meeting (updated)**

**NOTICE is hereby given** that the Annual General Meeting of the Kowloon Cricket Club will be held in the Sports Hall at the KCC Clubhouse, 10 Cox's Road, Jordan, Kowloon, Hong Kong SAR on Thursday 4 December 2025 at 6:30 p.m. for the purpose of: -

**As Ordinary Business: -**

1. To approve the Minutes of the following meeting:  
Annual General Meeting of the Club held on 5 December 2024;
2. To accept the 2024-25 Kowloon Cricket Club Annual Report and Accounts for the year ended 31 July 2025.
3. To appoint BDO Limited as Auditor of the Club for the ensuing year at a fee to be agreed with the General Committee of the Club in accordance with the provisions of Article 20 and 76 of the Articles of Association of the Kowloon Cricket Club.
4. To elect the following Officer of the Club for a term of two years in accordance with the provisions of Article 7.1 of the Articles of Association of the Kowloon Cricket Club:  
- Treasurer (There was only one nominee received for this position, no contested election is required).
5. To elect one (1) Member of the General Committee of the Club for a term of two years in accordance with the provisions of Article 7.1 of the Articles of Association of the Kowloon Cricket Club. (There was only one nominee received for this position, no contested election is required).
6. To endorse the Captain of Cricket and the Representatives of the Football, Hockey, Lawn Bowls, Squash and Tennis Sections who have been nominated by their respective Sections.
7. To consider the General Committee's proposal that the subscription payable monthly under Article 20 of the Articles of Association of the Kowloon Cricket Club be increased from HK\$1,700.00 to HK\$2,100.00 (HK\$300 will be credited each month to members for F&B and Pro-Shop expenses. All credits to be used within 1 calendar year, failing which the credits shall lapse automatically) with effect from 1 January 2026 in accordance with the provisions of Article 20 and 76 of the KCC Articles of Association.
8. To approve a 50% discount on OVM entrance fee for Members' Children subject to (1) Applicants' parents must be Special Voting Members or Ordinary Voting Members and have at least 10 years of continuous membership with paid monthly subscriptions by the time of the application (2) The applicant must be 23 or above but below 28 years old by the time of the application.
9. To approve that the Club staff shall receive at Chinese New Year 2026 a 13<sup>th</sup> month payment as bonus by way of the levying of one month subscription against each Member's account.
